TO: The Honorable Deborah Figgs-Sanders, Chair, and Members of City Council

SUBJECT: Approving the rescission of an unencumbered appropriation in the General Capital Improvement Fund (3001) in the amount of \$10,000 from the Infrastructure TBD FY24 Project (19776); approving a supplemental appropriation in the amount of \$10,000 from the increase in the unappropriated balance of the General Capital Improvement Fund (3001), resulting from the above rescission, to the Dwight Jones Storage Area Project (18631); and providing an effective date.

EXPLANATION: The Dwight Jones Center auditorium is a mixed-use space designed for events and play. Within the auditorium are numerous fold-up tables and chairs to be deployed for various activities, performances, and audiences. During times of non-use, these tables and chairs are openly stacked against the exterior wall and pose a potential hazard to anyone using the space for activities.

The Dwight Jones Storage Area Project provides for several custom-made cabinets to be furnished and installed along the exterior wall of the auditorium which will securely house the tables and chairs. These cabinets will not only provide a safe, lockable, storage solution, they will also be much more aesthetically pleasing.

RECOMMENDATION: Administration recommends that City Council adopt the attached resolution approving the rescission of an unencumbered appropriation in the General Capital Improvement Fund (3001) in the amount of \$10,000 from the Infrastructure TBD FY24 Project (19776); approving a supplemental appropriation in the amount of \$10,000 from the increase in the unappropriated balance of the General Capital Improvement Fund (3001), resulting from the above rescission, to the Dwight Jones Storage Area Project (18631); and providing an effective date.

COST/FUNDING/ASSESSMENT INFORMATION: A portion of the funding (\$50,000) for the project has been previously appropriated in the General Capital Improvement Fund (3001), Dwight Jones Storage Area Project (18631). Additional funding for the project will be available after approval of a rescission of an unencumbered appropriation in the General Capital Improvement Fund (3001) in the amount of \$10,000 from the Infrastructure TBD FY24 Project (19776) and a supplemental appropriation in the amount of \$10,000 from the increase in the unappropriated balance of the General Capital Improvement Fund (3001), resulting from the above rescission, to the Dwight Jones Storage Area Project (18631).

A RESOLUTION APPROVING THE RECISSION OF AN UNENCUMBERED APPROPRIATION IN THE GENERAL CAPITAL IMPROVEMENT FUND (3001) IN THE AMOUNT OF \$10,000 FROM THE INFRASTRUCTURE TBD FY24 PROJECT (19776); APPROVING A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$10,000 FROM THE INCREASE IN THE UNAPPROPRIATED BALANCE OF THE GENERAL CAPITAL IMPROVEMENT FUND (3001), RESULTING FROM THE ABOVE RECISSION, TO THE DWIGHT JONES STORAGE AREA PROJECT (18631); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, a portion of the funding (\$50,000) for the project has been previously appropriated in the General Capital Improvement Fund (3001), Dwight Jones Storage Area Project (18631) and additional funding will be available after approval of the recission of an unencumbered appropriation in the General Capital Improvement Fund (3001) in the amount of \$10,000 from the Infrastructure TBD FY24 Project (19776).

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that an unencumbered appropriation in the General Capital Improvement Fund (3001) in the amount of \$10,000 from the Infrastructure TBD FY24 Project (19776); is hereby rescinded.


