WHEREAS, the City of St. Petersburg ("City") is proud of its heritage and history;

WHEREAS, the Florida Department of State, Division of Historical Resources ("Division") has awarded a Small Matching Grant ("Grant") to the City in the maximum reimbursement amount of \$35,308 for the St. Petersburg Archaeological Parks Virtual Application Project ("Project"); and

WHEREAS, the Project includes creating a digital interpretive plan, a mobile application, and a web portal for four (4) archaeological parks in St. Petersburg including Abercrombie, Indian Mound, Jungle Prada/DeNarvaez, and Maximo Parks; and

WHEREAS, the Grant does not require matching contributions; and

WHEREAS, a supplemental appropriation of \$35,308 from the increase in the unappropriated balance of the General Capital Improvements Fund (3001) resulting from these additional revenues is required.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the Mayor or his designee is authorized to accept a Small Matching Grant ("Grant") for the St. Petersburg Archaeological Parks Virtual Application Project from the Florida Department of State, Division of Historical Resources ("Division") at a maximum reimbursement amount of \$35,308, and to execute an Agreement with the Division and all other documents necessary to effectuate the Grant; and
