**TO:** The Honorable Ed Montanari, Chair, and Members of City Council

**SUBJECT:** A resolution authorizing the Mayor or his designee to accept a \$390,832 grant from the U.S. Department of Justice ("DOJ"), Office for Victims of Crime ("OVC") to enhance victim services and to execute all documents necessary to effectuate this transaction; approving a supplemental appropriation in the amount of \$390,832 from the increase in the unappropriated balance of the Police Grant Fund (1702), resulting from these additional revenues, to the Police Department, Fiscal Support Division (140-1389), PD Victim Specialist Program Project (18129); and providing an effective date.

**EXPLANATION:** The City of St. Petersburg ("CITY") applied for a grant in the amount of \$390,832. The City will serve as the representative to this grant and will be responsible for the grant over its three-year life cycle. The City will submit expenditure documentation to DOJ for reimbursement of eligible costs. The grant requires no local matching funds. St. Petersburg Police Department will use the funding to hire two victim service specialists, pay for training, and supplies.

**RECOMMENDATION:** The administration recommends that City Council adopt the attached resolution authorizing the Mayor or his designee to accept a \$390,832 grant from the U.S. DOJ OVA to enhance victim services and to execute all documents necessary to effectuate this transaction; approving a supplemental appropriation in the amount of \$390,832 from the increase in the unappropriated balance of the Police Grant Fund (1702), resulting from these additional revenues, to the Police Department, Fiscal Support Division (140-1389), Victim Specialist 2020 Project (18129); and providing an effective date.

**COST/FUNDING INFORMATION:** Revenues of up to \$390,832 are to be received from the DOJ. The grant will fund victim services effective October 1, 2020 through September 30, 2023. A supplemental appropriation in the amount of \$390,832 from the increase in the unappropriated balance of the Police Grant Fund (1702), resulting from these additional revenues, to the Police Department, Fiscal Support Division (140-1389), PD Victim Specialist Program Project (18129) is required.

WHEREAS, the City of St. Petersburg ("CITY") applied for and has been awarded a grant from the DOJ, Office for Victims of Crime (OCV) in the amount of \$390,832 to enhance victim services; and

WHEREAS, the City will submit expenditure documentation to the DOJ for reimbursement of eligible costs; and

WHEREAS, a supplemental appropriation in the amount of \$390,832 from the increase in Police Grant Fund (1702), resulting from these additional revenues, to the Police Department, Fiscal Support Division (140-1389), PD Victim Specialist Program Project (18129) is required.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the Mayor or his designee is authorized to accept a \$390,832 grant from the U.S. Department of Justice, Office for Victims of Crime to enhance victim services and to execute all documents necessary to effectuate this transaction; and

**SUBJECT:** Proposed New Grant Funded Staff Positions Update – Law Enforcement-Based Victim Service Specialist (VS) Program

**Background:** New grant funded positions, grant match, and future maintenance costs are additional costs towards the city's budget. In 2017, BF&T members requested reporting grant applications which included new positions and the associated future costs to City Council. To date, the following is the third grant proposal that will add new staff positions as funded by the grant.

**Requesting City Department:** Police

**Name of Grant:** Law Enforcement-Based Victim Service Specialist Program

**Grantor Agency/Department:** (DOJ/OVW), Department of Justice, Office of Victims of Crimes

**Purpose:** This grant will enhance response to personal violence crimes through dedicated victim advocates who can assist sworn personnel with additional tasks of transporting victims, reading reports and follow-up tasks.

**Amount of Funds Requested/Received:** \$390,832

**Number of New Positions Requested:** Two FTE Victim Service Specialists (VSS salary and fringe for three years). Starting salary \$43K, with raises included for a period of three years. Funding also includes: Travel and Victim Services Practitioner Training through Attorney General; Office supplies; and Copy costs for pamphlets/materials.

**Grant Match:** No Match Required

**Grant Match Funding Source:** No Match Required

**Future Annual Costs:** *There is no grant requirement to retain the positions after the grant period has ended*

Congratulations on your recent award. 5. Required training for Point of Contact and all Financial Points of Contact

Both the Point of Contact (POC) and all Financial Points of Contact (FPOCs) for this award must have successfully completed an "OJP financial management and grant administration training" by 120 days after the date of the recipient's acceptance of the award. any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.

19. Effect of failure to address audit issues

24. Restrictions on "lobbying"

33. FFATA reporting: Subawards and executive compensation
