RESOLUTION NO. 2022-___

A RESOLUTION APPROVING A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$1,000,000 FROM THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND (0001) TO THE PARKS AND RECREATION DEPARTMENT, ADMINISTRATION DIVISION (190-1573), TO PROVIDE FUNDING FOR (I) STORM DEBRIS REMOVAL AND DISPOSAL SERVICES THAT ARE BEING PROVIDED BY CROWDER-GULF JOINT VENTURE, INC. AND (II) POST DISASTER DEBRIS MONITORING SERVICES THAT ARE BEING PROVIDED BY TETRA TECH INC. BECAUSE OF HURRICANE IAN; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of St. Petersburg, Florida ("City") and Crowder-Gulf Joint Venture, Inc. ("Crowder-Gulf") entered into a three-year agreement on January 1, 2021 for Crowder-Gulf to provide as needed storm debris removal and disposal services; and

WHEREAS, the City of St. Petersburg, Florida ("City") and Tetra Tech Inc. ("Tetra Tech") entered into a three-year agreement on April 27, 2022 for Tetra Tech to provide as needed post disaster debris monitoring services; and

WHEREAS, the City issues a notice to proceed for any work and services needed under these agreements; and

WHEREAS, on September 28–29, 2022, Hurricane Ian made landfall on the southwest coast of Florida at the island of Cayo Costa, near Fort Myers and Cape Coral, with sustained winds of approximately 150 mph; and

WHEREAS, a significant amount of debris was generated by Hurricane Ian in St. Petersburg, including downed trees and broken limbs; and

WHEREAS, due to the size and nature of that debris, it is frequently placed on the rightof-way for special collection by the City; and

WHEREAS, during a declared state of local emergency pursuant to Executive Order No. 2022-03, notice to proceeds were issued to Crowder-Gulf for debris removal and disposal services and Tetra Tech for post disaster debris monitoring services; and

WHEREAS, Crowder-Gulf is required to comply with certain FEMA requirements and Tetra Tech will monitor the services provided by Crowder-Gulf to ensure debris removal meets the federal requirement for reimbursement from FEMA; and

WHEREAS, in accordance with section 2-213 of the St. Petersburg City Code, Administration is hereby formally advising City Council of such actions and requesting funding for services being provided by Crowder-Gulf and Tetra Tech; and

WHEREAS, funding for services provided by Crowder-Gulf and Tetra Tech will be available after approval of a supplemental appropriation in the amount of \$1,000,000 from the unappropriated balance of the General Fund to the Parks and Recreation Department; and

WHEREAS, Administration recommends approval of this resolution.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that there is hereby approved the following supplemental appropriation from the unappropriated balance of the General Fund (0001) to the Parks and Recreation Department, Administration Division (190-1573) for Fiscal Year 2023 to provide funding for (i) storm debris removal and disposal services that are being provided by Crowder-Gulf Joint Venture, Inc. and (ii) post disaster debris monitoring services that are being provided by Tetra Tech Inc. because of Hurricane Ian:
