EXPLANATION: The privately owned structures on the attached list were condemned by the City in response to unfit or unsafe conditions as authorized under Chapter 8, Article VII of the St. Petersburg City Code. The City's Codes Compliance Assistance Department incurred costs of condemnation/securing/appeal/abatement/demolition and under the provisions of City Code Section 8-373, these costs are to be assessed to the property. The interest rate is 12% per annum on the unpaid balance.

A RESOLUTION SETTING JUNE 19, 2008 AS
THE DATE FOR PUBLIC HEARING ON
SPECIAL ASSESSMENTS ON BUILDING
DEMOLITION NO. 346 ("DMO 346"); AND
PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of St. Petersburg has proceeded under the provision of Chapter 8 of the St. Petersburg City Code to demolish certain structures; and

WHEREAS, the structures so demolished are listed on Building Demolition No. 346 ("DMO 346"); and

WHEREAS, Section 8-373 of the St. Petersburg City Code provides that the City Council shall assess the entire cost of demolition and that such assessment shall become a lien upon the property.

NOW, THEREFORE, BE IT RESOLVED By the City Council of the City of St. Petersburg, Florida, that this Council intends on June 19, 2008 to assess the cost of demolishing such buildings listed on Building Demolition No. 346 ("DMO 346"), and

BE IT FURTHER RESOLVED that preceding such determination of assessments the City Council, on June 19, 2008, shall hold a public hearing.

This resolution shall become effective immediately upon its adoption.
