A RESOLUTION APPROVING THE APPLICATION FOR CO-SPONSORED EVENT STATUS IN NAME ONLY FOR THE TAMPA BAY HEPATITIS & LIVER DISEASE SUPPORT GROUP, INC. ("APPLICANT") FOR AN AWARENESS PROGRAM TO BE HELD MAY 19, 2009 IN SOUTH STRAUB PARK FROM 10:00 A.M. TO 2:00 P.M., IN ACCORDANCE WITH CITY COUNCIL RESOLUTION NO. 2004-282, PROVIDED ALL CITY FEES ARE PAID 10 DAYS PRIOR TO THE EVENT TAKING PLACE; WAIVING SECTION "D" OF CITY COUNCIL RESOLUTION NO. 96-506 FOR THE APPLICANT; AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Tampa Bay Hepatitis & Liver Disease Support Group, Inc. ("Applicant") has applied for Co-sponsored Event Status in name only for Fiscal Year 2009 for an awareness program to be held May 19, 2009 in South Straub Park from 10:00 a.m. to 2:00 p.m.; and

WHEREAS, City Council previously adopted Resolution No. 2004-282 establishing a fee for review and approval of applications for Co-sponsored Event Status for applications made at times other than at the annual consideration of such applications; and

WHEREAS, the Applicant has paid the fee; and

WHEREAS, Section "D" of City Council Resolution No. 96-506 ("Section D") requires that all requests for co-sponsorship after the budget has been passed must be made no fewer than six (6) months prior to the first date of the event; and

WHEREAS, the application of the Applicant does not meet the Section D requirements; and

WHEREAS, in order for the City to enter into a contract with the Applicant, the provisions of Section D. must be waived by City Council; and

WHEREAS, the Administration and the Co-Sponsored Events Subcommittee have reviewed the application and recognize the proposed event as an event that will benefit the community and recommend that the waiver be granted and the application approved.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the application for co-sponsored event status in name only for the Tampa Bay Hepatitis & Liver Disease Support Group, Inc. ("Applicant") for an awareness

program to be held may 19, 2009 in South Straub Park from 10:00 a.m. to 2:00 p.m., in accordance with City Council Resolution No. 2004-282, is approved, provided all City fees are paid 10 days prior to the event taking place; and


BE IT FURTHER RESOLVED that section "D" of City Council Resolution No. 96-506 is waived as to the Applicant; and
