Subject: Renewing blanket purchase agreements with Bernie Marble Construction, Inc. d/b/a Emmett McCabe Trucking and J & K Enterprises of Largo, Inc. for road and landscape materials at an estimated annual amount of \$253,163.

Explanation: On March 20, 2008 City Council approved annual agreements for road and landscape materials that were purchased off Pinellas County Cooperative Bid No. 078-0129-B, effective through February 19, 2009. On April 17, 2008 City Council rescinded a blanket purchase agreement to All About Hauling, Inc and approved a change order to award a purchase agreement to J & K Enterprises of Largo, Inc. for the same term. Under the renewal of contract clause, these agreements may be renewed for a period of one year if mutually agreeable. This is the only renewal option, which will be effective through February 19, 2010.

The vendors furnish and deliver various grades of limestone, sand, crushed concrete and shell that are used to maintain streets and alleys. The primary users are the Stormwater, Pavement and Traffic Operations, Water Resources, Parks, and Engineering departments.

The Purchasing Department recommends for renewal, utilizing Pinellas County Bid No. 078-129-B:



The renewal will be effective from February 19, 2009 through February 18, 2010. The vendors have agreed to uphold the terms and conditions of Pinellas County Bid No. 078-129-B.

Cost/Funding/Assessment Information: Funds have been previously appropriated in the General Fund (0001), Transportation Planning Administration (2811797), Parks Administration (5102333) and Stormwater Traffic Administration (4001257), Water Resources Operating Fund (4001), Water Resources Administration (4202045), and in various capital improvement projects in the General Capital Improvement Fund (3001) and the Recreation and Culture Capital Improvement Fund (3029).

A RESOLUTION APPROVING THE RENEWAL OF AGREEMENTS (BLANKET AGREEMENTS) FOR THE PURCHASE OF ROAD AND LANDSCAPE MATERIALS WITH BERNIE MARBLE CONSTRUCTION, INC. D/B/A EMMETT MCCABE TRUCKING IN AN ESTIMATED ANNUAL AMOUNT NOT TO EXCEED \$104,343 AND J & K ENTERPRISES OF LARGO, INC. IN AN ESTIMATED ANNUAL AMOUNT NOT TO EXCEED \$148,820 FOR A TOTAL ESTIMATED ANNUAL AMOUNT NOT TO EXCEED \$253,163 UTILIZING PINELLAS COUNTY COOPERATIVE BID NO. 078-0129-B; AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS TRANSACTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on March 20, 2008 City Council approved the award of four Agreements (Blanket Agreements) to Bernie Marble Construction, Inc. d/b/a Emmett McCabe Trucking, J & K Enterprises of Largo, Inc., All About Hauling, Inc. and Cypress Creek Landscape Supply, Inc. pursuant to Pinellas County Cooperative Bid No. 078-129-B ("Pinellas County Bid"); for the purchase of various road and landscape materials; and

WHEREAS, subsequent to the award, All About Hauling, Inc. requested that the line item for #89 crushed limestone be removed from the Pinellas County Bid due to a computation error; and

WHEREAS, the next low bid on the Pinellas County Bid was the bid from J & K Enterprises of Largo, Inc. ("J & K"), therefore the Purchasing Department recommended and City Council approved the award of line item #89, crushed limestone, to J & K and approved a Change Order to the estimated annual amount of the Agreement with J & K; and

WHEREAS, the City desires to renew the Agreements with Bernie Marble Construction, Inc. d/b/a Emmett McCabe Trucking and J & K Enterprises of Largo, Inc.; and

WHEREAS, the Bernie Marble Construction, Inc. d/b/a Emmett McCabe Trucking and J & K Enterprises of Largo, Inc. have agreed to uphold the terms and conditions of Pinellas County Bid No. 078-129-B; and

WHEREAS, the Purchasing Department recommends renewal of these Agreements.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the renewal of the Agreements (Blanket Agreements) for the purchase of road and landscape materials with Bernie Marble Construction, Inc. d/b/a Emmett McCabe Trucking in an estimated annual amount not to exceed \$104,343 and J & K Enterprises

of Largo, Inc. in an estimated annual amount not to exceed \$148,820 for a total estimated annual amount not to exceed \$253,163 utilizing Pinellas County Cooperative Bid No. 078-0129-B is hereby approved and the Mayor or Mayor's Designee is authorized to execute all documents necessary to effectuate these transactions; and

BE IT FURTHER RESOLVED that the renewal of these Agreements will be effective from February 19, 2009 through February 18, 2010.

This Resolution shall become effective immediately upon its adoption.
