Subject: Renewing a blanket purchase agreement with H & H Liquid Sludge Disposal, Inc., for sludge removal and disposal for the Water Resources Department at an estimated annual cost of \$1,003,000.

Explanation: On February 16, 2006 City Council approved a two year blanket purchase agreement for sludge removal and disposal. Under the renewal of contract clause, the City reserves the right to extend the contract for a period of one year if mutually agreeable. This is the first of two one-year renewal options.

The vendor provides removal and disposal services for dewatered sludge produced at the four water reclamation facilities. The vendor provides tractor trailers and drivers to haul the sludge to approved disposal sites in Alturas, Bartow, Lake Wales, Lakeland and Punta Gorda. The estimated load size is 33-35 cubic yards.

The Purchasing Department in cooperation with the Water Resources Department recommends for renewal:

The vendor has agreed to hold prices firm under the terms and conditions of Bid No. 6485 dated January 3, 2006. The renewal will be effective through March 31, 2010.

A RESOLUTION APPROVING THE RENEWAL OF AN AGREEMENT (BLANKET AGREEMENT) WITH H & H LIQUID SLUDGE DISPOSAL, INC. FOR SLUDGE REMOVAL AND DISPOSAL AT AN ESTIMATED ANNUAL COST NOT TO EXCEED \$1,003,000 FOR THE WATER RESOURCES DEPARTMENT; AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS TRANSACTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on February 16, 2006 City Council approved the award of a two-year Agreement (Blanket Agreement) to H & H Liquid Sludge Disposal, Inc. with two one-year renewal options pursuant to RFP No. 6485 dated January 3, 2006; and

WHEREAS, the City desires to exercise the first one-year renewal option; and

WHEREAS, H & H Liquid Sludge Disposal, Inc. has agreed to uphold the terms and conditions of RFP No. 6485; and


WHEREAS, the Purchasing Department, in cooperation with the Water Resources Department, recommends renewal of this Agreement.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the renewal of the Agreement (Blanket Agreement) with H & H Liquid Sludge Disposal, Inc. for sludge removal and disposal at an estimated annual cost not to exceed \$1,003,000 is hereby approved and the Mayor or Mayor's Designee is authorized to execute all documents necessary to effectuate this transaction; and

BE IT FURTHER RESOLVED that the renewal of this Agreement will be effective through March 31, 2010.

This Resolution shall become effective immediately upon its adoption.
