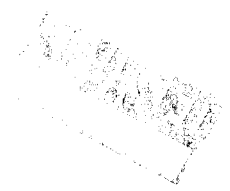

A RESOLUTION SETTING MARCH 5, 2009 AS THE DATE FOR PUBLIC HEARING ON SPECIAL ASSESSMENTS ON SECURING BUILDING NOS. SEC 1113 AND 1114 ("SEC 1113 AND 1114"); AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of St. Petersburg has proceeded under the provision of Chapter 8 of the St. Petersburg City Code to secure certain structures; and

WHEREAS, the structures so secured are listed on Securing Building Nos. 1113 and 1114, ("SEC 1113 and 1114"); and


WHEREAS, Section 8-373 of the St. Petersburg City Code provides that the City Council shall assess the entire cost of securing such buildings and that such assessment shall become a lien upon the property.

NOW THEREFORE, BE IT RESOLVED By the City Council of the City of St. Petersburg, Florida, that this Council intends on March 5, 2009, to assess the cost of securing such buildings listed on Securing Building Nos. 1113 and 1114 ("SEC 1113 and 1114"); and

BE IT FURTHER RESOLVED that preceding such determination of assessments the City Council, on March 5, 2009, shall hold a public hearing.

This resolution shall become effective immediately upon its adoption.
