**TO:** The Honorable Jeff Danner, Chair and Members of City Council

**SUBJECT:** Awarding a contract to Surge Restoration Solutions Group, Inc. in the amount of \$288,380.00 for Fleet Maintenance Facility Fueling Site Upgrades. (Engineering Project No. 07077-119, Oracle No. 10720).

**EXPLANATION:** The work consists of furnishing all labor, materials, services, and equipment necessary to remove existing single wall fuel tanks at the Fleet Maintenance Facility and construct replacement double wall tanks, in order to maintain compliance with Federal Department of Environmental Protection (FDEP) regulations. Work includes removal and closure of three (3) 10,000 gallon single wall above ground diesel storage tanks (AST) and one (1) 20,000 gallon single wall underground gasoline storage tank (UST), and construction of two (2) 15,000 gallon, double wall above ground diesel storage tanks and one (1) 20,000 gallon double wall underground gasoline storage tank, piping, electrical work for monitoring systems, and site restoration. Work will be phased to maintain fuel supplies for City operations at all times.

Replacement and closure of single wall USTs are required by December 31, 2009, and replacement and closure of single wall ASTs are required by January 1, 2010 pursuant to FDEP regulations requiring double wall tanks providing secondary containment for stored fuel.

The contractor will begin work approximately sixty (60) consecutive calendar days from written Notice to Proceed (approximately August, 2009) and is scheduled to complete work within ninety (90) calendar days thereafter. Bids were opened on April 14, 2009, and are tabulated as follows:

Administration recommends awarding this contract to Surge Solutions Group, Inc. in the amount of \$288,380.

WHEREAS, the contractor will begin work approximately sixty (60) consecutive calendar days from written Notice to Proceed; and


WHEREAS, replacement and closure of single wall USTs are required by December 31, 2009, and replacement and closure of single wall ASTs are required by January 1, 2010 pursuant to FDEP regulations requiring double wall tanks providing secondary containment for stored fuel; and


