On Thursday, May 21, 2009, the City Council Co-Sponsored Events Subcommittee conducted a meeting to review applications for City Co-Sponsored in "Name Only" from the Nite Riders Van Club, Inc. for an event entitled Saint Pete Live to be held July 25, 2009 in Vinoy Park from 7:00 p.m. to 10:00 p.m.; Albert Whitted Airfest, Inc. for an event entitled Rock 'n' Wings Concert to be held July 4, 2009 at Albert Whitted Airport from 4:00 p.m. to 10:00 p.m. and the World Triathlon Corporation for an event entitled Iron Kids Triathlon to be held June 6 and 7, 2009 in Spa Beach from 11:00 a.m. to 4:00 p.m. on June 6 and from 8:00 a.m. to 10:30 p.m. on June 7, 2009.

The Subcommittee reviewed each of the requests and recommended co-sponsorship In Name Only be granted. Councilmember Newton moved with the second of Councilmember Danner for:

1. Nite Riders: Saint Pete Live Concert
2. Airfest: Rock 'n' Wings Concert
3. World Triathlon: Iron Kids Triathlon

A RESOLUTION APPROVING THE APPLICATIONS FOR CO-SPONSORED EVENT STATUS IN NAME ONLY FOR THE NITE RIDERS VAN CLUB, INC. ("NITE RIDERS") FOR AN EVENT ENTITLED SAINT PETE LIVE TO BE HELD JULY 25, 2009 IN VINOY PARK FROM 7:00 P.M. TO 10:00 P.M.; ALBERT WHITTED AIRFEST, INC ("AIRFEST") FOR AN EVENT ENTITLED ROCK 'N' WINGS CONCERTS TO BE HELD JULY 4, 2009 IN ALBERT WHITTED AIRPORT FROM 4:00 P.M. TO 10:00 P.M.; AND WORLD TRIATHLON CORPORATION ("WORLD") FOR AN EVENT ENTITLED IRONKIDS TRIATHLON TO BE HELD JUNE 6 & 7, 2009 IN SPA BEACH PARK FROM 11:00 A.M. TO 4:00 P.M. ON JUNE 6 AND 8:00 A.M. TO 10:30 A.M. ON JUNE 7, IN ACCORDANCE WITH COUNCIL RESOLUTION NO. 2004-282, PROVIDED ALL CITY FEES ARE PAID 10 DAYS PRIOR TO THE EVENT TAKING PLACE; WAIVING SECTION "D" OF CITY COUNCIL RESOLUTION NO. 96-506 FOR ALL APPLICANTS; WAIVING CITY COUNCIL RESOLUTION NO. 2000-562(A) 8 AS TO WORLD; AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Nite Riders Van Club, Inc. ("Nite Riders") Albert Whitted Air Fest, Inc. ("Airfest") and World Triathlon corporation ("World") (collectively, "Applicants") have applied for Co-sponsored Event Status in name only for Fiscal Year 2009 for the following events:

Nite Riders: Saint Pete Live to be held July 25, 2009, in Vinoy Park from 7:00 p.m. to 10 p.m.:

Airfest: Rock 'N' Wings Concerts to be held July 4, 2009 at Albert Whitted Airport from 4:00 p.m. to 10 p.m.

World: IronKids Triathlon to be held June 6 & 7 in Spa Beach Park from 11:00 a.m. to 4:00 p.m. on June 6 and 8:00 a.m. to 10:30 a.m. on June 7.

WHEREAS, City Council previously adopted Resolution No. 2004-282 establishing a fee for review and approval of applications for Co-sponsored Event Status for applications made at times other than at the annual consideration of such applications; and

WHEREAS, the Applicants have paid the fee; and

WHEREAS, Section “D” of City Council Resolution No. 96-506 (“Section D”) requires that all requests for co-sponsorship after the budget has been passed must be made no fewer than six (6) months prior to the first date of the event; and

WHEREAS, the applications of the Applicants do not meet the Section D requirements; and

WHEREAS, City Council Resolution No. 2000-562(a) 8. requires:

The applicant agency [requesting co-sponsorship] must have been a non-profit or not for profit corporation, exempt from federal income tax (26 U.S.C. Sec. 501(c)(3) or similar federal tax provision) for a period of 1 year prior to the date of application and must provide a letter of endorsement for the event from the corporation’s board of directors. Proof of corporate existence and tax status are required at the time of making application.

WHEREAS, World does not meet the requirements of Resolution No. 2000-562(a)8; and

WHEREAS, in order for the City to enter into a contract with the Applicants, the provisions of Section D. must be waived by City Council; and

WHEREAS, in order for the City to enter into a contract with World, the provisions of Resolution No. 2000-562 (a) 8 must be waived by City Council; and

WHEREAS, the Administration and the Co-Sponsored Events Subcommittee have reviewed the applications and recognize the proposed events as events that will benefit the community and recommend that the waivers be granted and the applications approved.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the applications for Co-Sponsored Event Status in name only for the Nite Riders Van Club, Inc. (“Nite Riders”) for an event entitled Saint Pete Live to be held July 25, 2009 in Vinoy Park from 7:00 p.m. to 10:00 p.m.; Albert Whitted Airfest, Inc (“Airfest”) for an event entitled Rock ’N’ Wings Concerts to be held July 4, 2009 in Albert Whitted Airport from 4:00 p.m. to 10:00 p.m.; and World Triathlon Corporation (“World”) for an event entitled IronKids Triathlon to be held June 6 & 7, 2009 in Spa Beach Park from 11:00 a.m. to 4:00 p.m. on June 6 and 9:00 a.m. to 10:30 a.m. on June 7, in accordance with Council Resolution No. 2004-282, are approved, provided all City fees are paid 10 days prior to the event taking place; and

BE IT FURTHER RESOLVED that section “D” of City Council Resolution No. 96-506 is waived as to all applicants; and

BE IT FURTHER RESOLVED that the and the requirements of City Council Resolution


No. 2000-562(a) 8; are waived as to World; and

BE IT FURTHER RESOLVED that the Mayor or his designee is authorized to execute all documents necessary to effectuate this resolution.

This resolution shall take effect immediately upon its adoption.
