Subject: Approving a supplemental appropriation not to exceed \$30,000 from the increase in the unappropriated balance of the General Fund resulting from sponsorship and registration fees collected for the 13th Annual Florida Neighborhoods Conference.

Explanation: The City of St. Petersburg will host the 13th Annual Florida Neighborhoods Conference from July 9 – 11, 2009 at the Hilton St. Petersburg Bayfront. Monies to cover the expenses for the conference will be funded through sponsorships and conference registration fees. Several conference items will be provided as in-kind sponsorship. In addition to the Hilton, our sponsors include: Neighborhood Partner – Progress Energy; Good Neighbors – St. Petersburg Clearwater CVB, St. Anthony's Hospital, City of Hollywood, City of Tallahassee, City of Tampa/Hillsborough County; and Contributing Neighbors – Constellation Energy and SweetBay Supermarket.

Cost/Funding/Assessment Information: Funding for the Florida Neighborhoods Conference will require a supplemental appropriation of \$30,000 from the increase in the unappropriated balance of the General Fund resulting from these additional revenues. Sponsorships and registration fees collected will be the funding source.

A RESOLUTION APPROVING A SUPPLEMENTAL APPROPRIATION NOT TO EXCEED \$30,000 FROM THE INCREASE IN THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND FOR THE 13TH ANNUAL FLORIDA NEIGHBORHOODS CONFERENCE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida Neighborhoods Conference (FNC) is a statewide conference which provides informational and networking opportunities for Florida's residents involved in community based efforts; and

WHEREAS, the City of St. Petersburg, Florida ("City") is one of the founding members of the FNC; and

WHEREAS, the City of St Petersburg agreed to host the 13th Annual Florida Neighborhoods Conference from July 9 – 11, 2009 at the Hilton St. Petersburg Bayfront ("Hilton"); and

WHEREAS, Progress Energy, the St. Petersburg-Clearwater Convention and Visitors' Bureau, St. Anthony's Hospital, City of Hollywood, City of Tallahassee, SweetBay Supermarket, City of Tampa, Hillsborough County and Constellation Energy have joined in partnership with the Hilton and the City; and

WHEREAS, a supplemental appropriation, funded from sponsorships and registration fees, in the amount of \$30,000 is necessary to pay for the conference expenses.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that there is hereby approved from the unappropriated balance of the General Fund the following supplemental appropriation for fiscal year 2009:
