SUBJECT: Authorizing the Mayor or his designee to execute Task Order No. 08-2-BV/W to the Agreement between the City of St. Petersburg and Black & Veatch Corporation in the not to exceed amount of \$170,000 for construction phase engineering services for the Washington Terrace Pumping Station Improvements. (Engineering Project No. 03064-111; Oracle No. 10068)

EXPLANATION: On August 25, 2000, the City Council approved a Master Agreement with the professional consulting engineering firm of Black & Veatch Corporation for Miscellaneous Professional Services for Potable Water, Wastewater and Reclaimed Water Projects.

Task Order No. 00-06-BV, was approved by City Council on May 1, 2003 in the not-to-exceed amount of \$118,700, and provided for the preparation of a basis of design report to evaluate emergency power generation, and control system improvements to the Washington Terrace Pumping Station necessary to improve potable water distribution system operations, enhance remote operation and control capabilities, and replace aging and unreliable equipment. The total value of the work authorized by the Notice to Proceed on May 28, 2003 was \$108,700.

Task Order No. 00-06-BV, Amendment No. 1, approved by City Council on January 20, 2005 in the not-to-exceed amount of \$201,100, and provided for detailed design, permitting, and bidding phase services for the proposed modifications and renovations to the Washington Terrace Pumping Station. The total value of the work authorized by the Notice to Proceed on February 3, 2005 was the not-to exceed amount of \$181,100.

Task Order No. 00-04-BV, Amendment No. 1, Revision No. 1 was approved by administration on May 15, 2006 in the not-to-exceed amount of \$30,000, and provided for supplemental design services.

Task Order No. 00-04-BV, Amendment No. 1, Revision No. 2 was approved by administration on January 17, 2007 for a lump sum fee of \$24,900, and provided for support services for the direct purchase of the emergency engine generator and related equipment.

On November 21, 2008, the City Council approved a new Master Agreement with the professional consulting engineering firm of Black & Veatch Corporation for Miscellaneous Professional Services for Potable Water, Wastewater and Reclaimed Water Projects.

Task Order No. 08-2-BV/W, in the amount not to exceed \$170,000 provides for construction phase services including attendance at the preconstruction conference, responses to requests for information, shop drawing review, review of change order requests, meetings and site visits, pre-final and final inspections of the work, and preparation of as-built/record drawings to complete the construction for the Washington Terrace Pumping Station Improvements project.

RECOMMENDATION: Administration recommends approval of Task Order No. 08-2-BV/W with Black & Veatch Corporation for the not-to-exceed amount of \$170,000. This will increase the total Task Orders cost to \$514,700.
