TO: The Honorable Jeff Danner, Chair, and Members of City Council

SUBJECT: A resolution authorizing the Mayor or his designee to accept a supplemental award increase in the amount of \$17,000 to a U.S. Department of Justice grant to pay police department investigative overtime costs for joint cases with the U.S. Bureau of Alcohol, Tobacco, Firearms and Explosives and to execute all documents necessary to effectuate this transaction; approving a supplemental appropriation in the amount of \$17,000 from the increase in the unappropriated balance of the General Fund (0001) resulting from these additional revenues to the Police Department; and providing an effective date.

EXPLANATION: The City has previously received a grant award of \$8,000, which was later increased by \$4,500, from the U.S. Department of Justice for overtime costs for joint cases with the U.S. Bureau of Alcohol, Tobacco, Firearms, and Explosives ("ATFE"), on a reimbursement basis. The grant required no local matching funds and was approved and appropriated by resolution of City Council on June 4, 2009. In conjunction with that award, the Administration executed a Memorandum of Agreement ("MOA") with ATFE setting forth the reimbursement procedure. ATFE, by Increase No. 2, pursuant to the MOA, has increased the amount of the grant by \$17,000. The increase requires no matching funds. These additional funds require a supplemental appropriation to the Police Department

RECOMMENDATION: The administration recommends that City Council adopt the attached resolution authorizing the Mayor or his designee to accept a supplemental award increase in the amount of \$17,000 to a U.S. Department of Justice grant to pay police department investigative overtime costs for joint cases with the U.S. Bureau of Alcohol, Tobacco, Firearms and Explosives and to execute all documents necessary to effectuate this transaction; approving a supplemental appropriation in the amount of \$17,000 from the increase in the unappropriated balance of the General Fund (0001) resulting from these additional revenues to the Police Department; and providing an effective date.

COST/FUNDING INFORMATION: The grant will provide funds through September 30, 2009. A supplemental appropriation in the amount of \$17,000 from the increase in the unappropriated balance of the General Fund (0001) resulting from these additional funds, to the Police Department Vice & Narcotics (140-1445) is required.

A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ACCEPT A SUPPLEMENTAL AWARD INCREASE IN THE AMOUNT OF \$17,000 TO A U.S. DEPARTMENT OF JUSTICE GRANT TO PAY POLICE DEPARTMENT INVESTIGATIVE OVERTIME COSTS FOR JOINT CASES WITH THE U.S. BUREAU OF ALCOHOL, TOBACCO, FIREARMS AND EXPLOSIVES AND TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS TRANSACTION; APPROVING A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$17,000 FROM THE INCREASE IN THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND (0001) RESULTING FROM THESE ADDITIONAL REVENUES TO THE POLICE DEPARTMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of St. Petersburg Police Department assists the U.S. Bureau of Alcohol, Tobacco, Firearms and Explosives (“ATFE”) with certain investigations; and

WHEREAS, the City has previously been awarded a U.S. Department of Justice (“DOJ”) grant in the amount of \$8,000, which was later increased by \$4,500, to pay for City employee investigative overtime costs for those joint ATFE investigations, and

WHEREAS, DOJ has increased the previous grant award by \$17,000 by issuance of Increase No. 2 pursuant to the Memorandum of Agreement between the City and ATFE; and

WHEREAS, 100% of the grant funds will be allocated to the Police Department to cover investigative overtime cost, and

WHEREAS, a supplemental appropriation of \$17,000 from the increase in the unappropriated balance of the General Fund (0001) resulting from these additional funds is required.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the Mayor or his designee is authorized to accept a supplemental award increase in the amount of \$17,000 to a U.S. Department of Justice grant to pay Police Department investigative overtime costs for joint cases with the U.S. Bureau Of Alcohol, Tobacco, Firearms and Explosives and to execute all documents necessary to effectuate this transaction; and




BE IT FURTHER RESOLVED that there is hereby approved from the increase in the
