SUBJECT: Report of Co-Sponsored Events Subcommittee Recommendation for Co-Sponsored Events in "Name Only" for eight (8) events to be held in the City of St. Petersburg, Florida.

On Wednesday, September 16, 2009 at 9:13 a.m., the City Council Co-Sponsored Events Subcommittee conducted a meeting to review applications requesting city co-sponsorship in "Name Only" for fiscal year 2010. A total of eight applications were reviewed.

The subcommittee reviewed each of the requests and recommended in "Name Only" co-sponsorship as on the following list. Once these co-sponsored in "Name Only" are approved, staff will proceed to officially notify groups and complete legal contracts with them.

- Relay for Life (May 14, 15, 2010 – St. Petersburg High School)
- Relay for Life (April 16, 17, 2010 – Spa Beach)
