SUBJECT: Awarding a contract to TLC Diversified, Inc. in the amount of \$706,506.00 for the construction of the Lift Station 61/Pasadena Master Rehabilitation Project located at 6800 Travelers Way South. (Engineering Project No. 06066-111; Oracle No. 10978)

EXPLANATION: The work consists of furnishing all labor, material, equipment, incidentals and services necessary for the rehabilitation of Lift Station No. 61/Pasadena Master. The work includes converting the existing wetwell and dry-pit pumping system to an in-line booster pumping system, modification of the pump's suction piping; removal and replacement of the electrical and instrumentation systems associated with the conversion; upgrades to the existing System Control and Data Acquisition (SCADA) system; repair and filling of the abandoned wet well pit with flowable fill; construction of new By-Pass Pit No. 2; installation of new magnetic flow meters; installation of piping and electrical service. Site repairs and upgrades involve constructing an asphalt overlay on the driveway; and restoration of surfaces.

The existing wetwell was last rehabilitated in 1995 and is currently in a deteriorated condition. This project will eliminate the wetwell resulting in reduced maintenance and odor control costs for this pumping station.

The contractor will begin work approximately ten (10) days from written Notice to Proceed and is scheduled to complete the work within two-hundred seventy (270) consecutive calendar days thereafter. Bids were opened on August 26, 2009 and are tabulated as follows:

The responsive low bidder, TLC Diversified, Inc. has satisfactorily performed similar lift Station construction projects in the past for the City of St. Petersburg, City of Clearwater, Sarasota County, and Indian River County Utilities. Principals of the firm are Thurston Lamberson, President and Joanne Lamberson, Vice President/Secretary.

Administration recommends awarding this Contract to TLC Diversified, Inc., in the amount of \$706,500.




