Subject: Approving the purchase of resurfacing services from E.J. Breneman, L.P. for the Engineering and Capital Improvements Department at a total cost of \$390,150.

Explanation: This purchase is being made from Orange County Construction Term Contract No. Y7-1006 for cold recycled bituminous base course. The vendor will provide all labor, material, equipment and supplies necessary to reconstruct the roadway base of 22nd Avenue North from 58th Street to Tyrone Boulevard. The single pass reconstruction process consists of scarifying and recycling the existing surface, applying an asphalt recycling agent and thoroughly remixing to a depth of six inches, reshaping the existing asphalt surface in compliance with lines, grades and thickness as determined by the Engineering and Capital Improvements Department and compacting the surface.

The Purchasing Department, in cooperation with the Engineering and Capital Improvements Department recommends for award:

Approx. 27,000 sq yds cold in-place recycling @ \$10.65/sq yd
Approx. 54,000 gallons emulsion @ \$1.90/ga


E.J. Breneman, L.P. has met the specifications, terms and conditions of Term Contract No. Y7-1006 dated May 14, 2007. The vendor has provided this service to the City in the past and has performed satisfactorily. This purchase is made in accordance with Section 2-234 (e) of the City Code which authorizes the Mayor or his designee to purchase services from a competitively bid proposal or contract secured by State, County or municipal government.

Cost/Funding/Assessment Information: Funds are available in the Neighborhood and Citywide Infrastructure Capital Improvement Fund (3027), 22 Ave North (58th Street to Tyrone Blvd) Project (TBD).

A RESOLUTION APPROVING THE AWARD OF AN AGREEMENT TO E.J. BRENEMAN, L.P. FOR THE PURCHASE OF RESURFACING SERVICES FOR THE ENGINEERING AND CAPITAL IMPROVEMENTS DEPARTMENT AT AN ESTIMATED TOTAL COST NOT TO EXCEED \$390,150 UTILIZING ORANGE COUNTY CONSTRUCTION TERM CONTRACT NO. Y7-1006; AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS TRANSACTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 2-234(e) of the City Code the City is permitted to utilize competitively bid contracts of other governmental entities when it is in the best interest of the City; and

WHEREAS, E.J. Breneman, L.P. has met the specifications, terms and conditions of Orange County Construction Term Contract No. Y7-1006 for resurfacing services; and

WHEREAS, the Purchasing Department, in cooperation with the Engineering and Capital Improvements Department, recommends approval of this award.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida that approval of the award of an agreement with E.J. Breneman, L.P. for the purchase of resurfacing services for the Engineering and Capital Improvements Department at an estimated total cost not to exceed \$390,150 utilizing Orange County Construction Term Contract No. Y7-1006 is hereby approved and the Mayor or Mayor's Designee is authorized to execute all documents necessary to effectuate this transaction.
