**TO:** The Honorable Jeff Danner, Chair, and Members of City Council

**SUBJECT:** Awarding a contract to Traffic Calming USA in the amount of \$187,250.00 for the 49<sup>th</sup> Street South Corridor Improvements. (Engineering Project No. 09051-119; Oracle No. 12062)

**EXPLANATION:** The work consists of furnishing all labor, materials, services, and equipment necessary to install textured, colored, brick imprint crosswalk surfaces along 49<sup>th</sup> Street South, at the intersections of 22<sup>nd</sup> Avenue South, 20<sup>th</sup> Avenue South, 18<sup>th</sup> Avenue South, 15<sup>th</sup> Avenue South, and 11<sup>th</sup> Avenue South. Work also includes textured, brick imprint median surfaces at selected locations within the existing center turn/auxiliary lane on 49<sup>th</sup> Street South from 22<sup>nd</sup> Avenue South to 10<sup>th</sup> Avenue South.

Work includes the following approximate quantities: milling of approximately 1,750 square yards of existing asphaltic surface and replacement with a thermoplastic blend material to be stamped to create a textured surface.

Pursuant to an interlocal agreement approved by the St. Petersburg City Council on September 3, 2009, this project was developed and jointly funded by the Cities of Gulfport and St. Petersburg. The joint project will include the use of Gulfport CDBG funds and the City's General Capital Improvement Fund (3001) and the Neighborhood and Citywide Infrastructure Capital Improvement Fund (3027), 49<sup>th</sup> Street Improvements Project (12062). The CDBG funds are required to be expended by December 31, 2009.

The contractor will begin work approximately ten (10) calendar days from written Notice to Proceed and is scheduled to complete work within forty (40) consecutive calendar days thereafter. Bids were opened on September 30, 2009, and are tabulated as follows:

Traffic Calming USA (Hiram, GA)	\$ 187,250.00
Kilgore Construction, LLC (Largo, FL)	\$ 322,500.00
Engineer's Estimate	\$ 192,500.00

The low bidder, Traffic Calming USA, has satisfactorily performed similar work for the FDOT, City of St. Petersburg and the City of Jacksonville. The principal of the firm is Glyn Owen, President.

**RECOMMENDATION:** Administration recommends awarding this contract to Traffic Calming USA in the amount of \$187,250.00

**COST/FUNDING/ASSESSMENT INFORMATION:** Funds are available in the Neighborhood and Citywide Infrastructure Improvement Fund (3027), 49<sup>TH</sup> Street Improvement Project (12062).


