**Subject:** Awarding a two-year blanket purchase agreement to Buccaneer Landscape Management Corporation for truck watering services at an estimated annual cost of \$211,500.

**Explanation:** The Purchasing Department received two bids for truck watering services. The vendor will provide truck watering services for trees, shrubs and miscellaneous landscape materials at public parks, buildings, and in street and highway right-of-ways throughout the city.

The Purchasing Department in cooperation with the Engineering & Capital Improvements and Parks Horticulture Operations Department, recommends for award:

Buccaneer Landscape Management Corporation..... \$211,500


Buccaneer Landscape Management Corporation, the low bidder, has met the specifications, terms and conditions of IFB No. 6852 dated July 30, 2009. They are a St. Petersburg based company and have been in business since March of 2006. They have provided similar services for City of Tampa, City of Largo and CVS Pharmacy and have performed satisfactorily. This agreement will be effective from date of award through November 30, 2011 with three one-year renewal options by mutual agreement. A blanket purchase agreement will be issued to the vendor and will be binding only for actual services rendered.

**Cost/Funding/Assessment Information:** Funds will be appropriated in the General Fund (0001), Parks Horticulture Operations (5102381) and Recreation and Culture Capital Improvement Fund (3029) for various projects.

A RESOLUTION ACCEPTING THE BID AND APPROVING THE AWARD OF A TWO-YEAR AGREEMENT (BLANKET AGREEMENT) WITH THREE ONE-YEAR RENEWAL OPTIONS TO BUCCANEER LANDSCAPE MANAGEMENT CORPORATION FOR TRUCK WATERING SERVICES AT AN ESTIMATED ANNUAL COST NOT TO EXCEED \$211,500; AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS TRANSACTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Purchasing Department received two bids for truck watering services pursuant to IFB No. 6852 dated July 30, 2009; and

WHEREAS Buccaneer Landscape Management Corporation has met the specifications, terms and conditions of Bid No. 6852; and


WHEREAS, the Purchasing Department, in cooperation with the Engineering & Capital Improvements and Parks Horticulture Operations Department, recommends approval of this award.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the bid and award of a two-year agreement (Blanket Agreement) with three one-year renewal options to Buccaneer Landscape Management Corporation for truck watering services at an estimated annual cost not to exceed \$211,500 is hereby approved and the Mayor or Mayor's Designee is authorized to execute all documents necessary to effectuate this transaction; and

BE IT FURTHER RESOLVED that this agreement will be effective from the date of award through November 30, 2011.

This Resolution shall become effective immediately upon its adoption.
