SUBJECT A Resolution by City Council approving amendments to the FY 2022

project plan for the South St. Petersburg Community Redevelopment Area (CRA) to reallocate \$4,640,158 in funding from allocations in the Workforce, Education and Job Readiness, Business and Commercial Development, and Communications, Evaluation and Operations categories to the Housing and Neighborhood Revitalization program

categories; and providing an effective date.

RECOMMENDATION Administration recommends City Council approve the attached

Resolution.

Overview of Recommended Actions on FY 2022 CRA Budget

City Council **APPROVE** the following actions regarding the project plan for the FY 2022 budget for the South St. Petersburg CRA:

- Increase the CRA Housing and Neighborhood Revitalization allocation by \$4,640,158 to meet expected public funding requests for affordable housing projects in the CRA.
- Allocate the increase to the "Developer Incentive Program" which includes the "Affordable Housing Redevelopment Loan Program" and the "Affordable Residential Property Improvement Grant".
- Reduce the allocations in the three other budget categories in the following manner:

 Allocate \$563,000 in the "Property Acquisition and Site Preparation" allocation in the Housing and Neighborhood Revitalization budget to the "Developer Incentive Program."
 The new funding available for this program will be increased to \$5,203,158.

Background on FY 2022 CRA Budget Amendment

In December 2021, City Council approved the FY22 South St. Petersburg CRA Budget of \$13,009,038. The funding was allocated for use according to the following categories:

Within the Housing and Neighborhood Revitalization budget, funding was allocated within three categories – Property Acquisition and Site Preparation, Developer Incentives, and Single Family Programs. Table 1 below shows the original budget amounts and current balance within the Housing and Neighborhood Revitalization budget.

Since the budget was approved, City Administration has been negotiating with affordable housing developers whose projects would construct or renovate more than 440 units with potential funding needs of \$5.53 million. These projects include

Fairfield Apartments – 264 units in 3300 blk Fairfield Ave S	\$2.28 million
Lakeside Complex Rehab – 44 units in 500 blk 18 th Ave S	\$600,000

Table 2 below depicts all of the projects the Housing and Community Development and Economic and Workforce Development are expecting to request FY22 CRA funding from the City in the coming months. The funding would be made available through the CRA Developer Incentive Program, which includes the Affordable Housing Redevelopment Loan Program and the Affordable Residential Property Improvement Grant (aka RRR+).

In total, staff has projected housing funding requests of \$5.53 million in CRA funding for 452 units that are far in excess of the available funding in the approved housing budget of \$2.135 million. The available funding from the Housing and Neighborhood Revitalization budget to meet the demand is significantly less than the approved budget because of encumbered funding in the Developer Incentive line item currently leaving \$263,532 to meet the demand. Combined with \$563,000 in funding from the Property Acquisition and Site Preparation program, the CRA Housing budget has only \$916,532 to support the potential funding requests identified above.

Recommended Reductions to CRA FY 2022 Budget

To fund the expected housing obligations, the City will need an additional **\$4.64 million** in funding from other CRA programs, such as the commercial development, youth readiness, and early childhood education programs that are demand driven and also staff intensive, which have not been launched yet in FY22.

In addition to the remaining balance of \$916,532 from the Housing budget, staff identified approximately \$2.33 million in cuts from the Commercial Revitalization, \$1.03 million from Workforce Development, Education and Job Readiness, and \$1.29 million from CRA Communications, Evaluation and Operations budget categories. Table 3 below identifies the reductions for each program as well as the reason for the recommendation. These funding cuts to augment the housing budget will cover the expected housing requests and leave approximately \$23,690 available.

The Commercial Revitalization Program and Commercial Matching Grant FY22 Program are recommended for a reduction in their entire budgets, totaling \$700,000. Both programs require a revamping based on comments from City Council over the last two cycles. City Council has requested a Committee of the Whole to discuss improvements to the program, but it has not yet been scheduled. At any rate, City staff is not intending to launch another round of either program until input is received from the Mayor's Office and City Council. To still provide commercial funding to CRA businesses, Economic and Workforce Development will focus on launching the Redevelopment Microfund Program during summer 2022.

Staff is also recommending that \$1.5 million in funding for the Tangerine Plaza Commercial Buildout be eliminated. The funding will not be needed for this project until FY23 and sufficient revenue will be available to cover the costs.

The **Sankofa Commercial Buildout** line item was designed to provide an annual payment towards bond financing for the project. This annual payment will not be needed in FY22. However, the **\$300,000** funding allocation is being retained in the line item to pay for approximately \$200,000 in environmental cleanup costs on the site. In the original approved FY22 budget, the Sankofa allocation was placed in the "Property Acquisition and Site Preparation" line item which also allows for environmental cleanup among other activities. Therefore, no formal budget amendment is needed to redeploy the funding.

Finally, staff is recommending eliminating **\$125,000** in funding for the **Emergency Grant** and **Cleanup of 22**nd **Street Lots,** with the latter funding unnecessary as all remediation has been completed on these two City lots north of the Royal Theater.

Staff is recommending reducing funding allocations for the **Youth Farm and Curriculum Manager** positions by **\$180,000**. The two manager positions were put out to RFQ in 2022 but there were no respondents. Staff is awaiting the completion of the Youth Farm site improvements, which will potentially attract more interested parties to fill these positions. This funding can be replaced by FY23 revenue if City Administration desires.

In addition, staff is recommending sweeping \$550,000 in funding to affordable housing from the Capacity Building for Family Child Care Centers (Family Child Care) and the Academy for Business in Child Care Development (ABCD) programs. Both of these programs are run out of the Greenhouse and rely heavily on it for mentoring and training. With the reduced staffing levels at the Greenhouse caused by the departure of its manager as well as another vacancy, City staff does not have the capacity to deliver the program in this fiscal year. However, Family Child Care centers are able to take advantage of the Redevelopment Microfund Program when it is launched in the summer with the same funding levels available to it that are offered by Family Child Care program.

Finally, staff is recommending reducing by \$300,000 the funding approved for the Workforce Development Program. The remaining \$950,000 in funding is to cover expenditures related to the workforce development contract with St. Petersburg College. The additional \$300,000 was to seed an enhanced construction training program to ramp up CRA residents in the trades. That program has not yet been developed.

Staff is recommending sweeping \$585,158 in funding for affordable housing from the 34th Street South Plan, Future Plans and Deuces/WADA budget line items. The \$300,000 in Deuces/WADA funding was to be paired with \$1.2 million in funding from the American Relief Plan Act (ARPA) to construct the festival street for 22nd Street South between 9th

Avenue South and 11th Avenue South. However, the ARPA funding was repurposed by City Administration to address affordable housing issues. (The Deuces/WADA project can be potentially funded in future budget years upon the approval of the proposed **Commercial Corridor Planning and Implementation Program** that is currently being created in the Economic and Workforce Development Department.) The other two plan-related allocations can be shifted to the FY23 CRA budget without impact.

Likewise, the **Community Safety Innovations** program, with its **\$300,000** allocation, is currently in its preliminary draft stages and will not require funding from the FY22 CRA budget. It can be funded from the FY23 budget if Administration and City Council approve. Staff is also recommending that funding for the **CRA Impact Study** be swept for affordable housing and reallocated in the FY23 budget. The study, which will evaluate the impacts of the CRA programs on its residents, will involve an ongoing contractual relationship with an institution to conduct these evaluations until 2045 when the South St. Petersburg CRA will sunset.

Finally, City staff is recommending reducing the **CRA Marketing** allocation from **\$400,000** to \$150,000. The prior administration significantly increased the marketing budget from \$50,000 to \$400,00 to pay for outside consultant(s) to promote the CRA and its programs as well as to highlight the successes and outcomes of its investments. It was felt the traditional marketing approaches were not reaching the South St. Petersburg residents and alternative strategies were needed to ensure the citizens were aware of the programs that were available to them. An outside consultant has not yet been sought but staff recommends retaining \$150,000 for the Mayor's Office "youth based task force" that will spearhead a "mini census" to survey residents and businesses as well as marketing efforts in the summer along the 16th Street South corridor.

Recommended Additions FY 2022 CRA Housing Budget Plan

The recommended CRA budget reductions above will yield approximately \$4.64 million available to fund expected demand for CRA affordable housing. Approximately \$36,468 of this funding will be allocated to the "Affordable Residential Property Improvement Grant" (RRR+) program to assist expected demand of \$300,000 for this program. The remaining funding will be allocated to the "Affordable Housing Redevelopment Loan Program." In addition, staff is also recommending moving \$563,000 in funding from the "Property Acquisition and Site Preparation" allocation to the "Affordable Housing Redevelopment Loan Program." With a current balance of \$90,000, these amendments will provide \$5.256 million for the Loan Program and a total allocation for the Developer Incentive program of \$5.56 million, approximately \$24,000 more than the expected demand for CRA funding support identified in Table 2 above. Table 6 below shows the distribution of the funding.

A RESOLUTION BY ST. PETERSBURG CITY COUNCIL APPROVING AMENDMENTS TO THE FY 2022 PROJECT PLAN FOR THE SOUTH **PETERSBURG** COMMUNITY REDEVELOPMENT **AREA** (CRA) TO REALLOCATE \$4,640,158 IN FUNDING FROM ALLOCATIONS IN THE WORKFORCE, EDUCATION AND JOB READINESS. BUSINESS AND **COMMERCIAL** DEVELOPMENT, AND COMMUNICATIONS, AND **EVALUATION OPERATIONS** CATEGORIES TO THE HOUSING NEIGHBORHOOD REVITALIZATION PROGRAM CATEGORIES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of St. Petersburg City Council approved a Community Redevelopment Plan (Plan) for the South St. Petersburg CRA on May 21, 2015 (Ord. #169-H), which included establishment of a tax increment financing district and redevelopment trust fund for the entire 7.4-sq.mi. South St. Petersburg CRA;

WHEREAS, on December 16, 2021, City Council approved Resolution #21-631 adopting the project plan for the FY 2022 budget of \$13,009,038 for the South St. Petersburg CRA;

WHEREAS, the FY 2022 project plan for the South St. Petersburg CRA budget provided approximately \$3.051 million for Housing and Neighborhood Revitalization, \$2.697 million for Workforce, Education and Job Readiness, \$5.116 million for Business and Commercial Development and \$2.146 million for Communications, Evaluation and Operations (see Exhibit 1);

WHEREAS, since the budget was approved, City Administration has been negotiating with affordable housing developers whose projects would construct or renovate more than 440 units with potential funding needs of \$5.53 million;

WHEREAS, the available funding from the Housing and Neighborhood Revitalization budget to meet the demand is significantly less than the approved budget because of encumbered funding currently leaving \$263,532 to meet the projected demand;

WHEREAS, City Administration is recommending addressing the funding needs of projected affordable housing demand by reducing by \$4,640,158 in unencumbered funding from the project plans for the Workforce, Education and Job Readiness, Business and Commercial Development and Communications, Evaluation and Operations budgets as detailed in Tables 1 through 4 in Exhibit 1;

WHEREAS, at its July 5, 2022, meeting, the Citizen Advisory Committee for the St. Petersburg Community Redevelopment Area recommended to the St. Petersburg Community

Redevelopment Agency that City Council approve the proposed amendments to the project plan for the FY 2022 budget for the South St. Petersburg CRA; and

WHEREAS, at its August 18, 2022, meeting, the St. Petersburg Community Redevelopment Agency recommended that City Council approve the proposed amendments to the to the project plan for the FY 2022 budget for the South St. Petersburg CRA.

NOW, THEREFORE, BE IT RESOLVED, that the St. Petersburg City Council approves amending the FY 2022 project plan for the South St. Petersburg Community Redevelopment Area to reallocate \$4,640,158 in funding from the program plans of the Business and Commercial Development, Workforce, Education and Job Readiness, and the Communications, Evaluation and Operations program categories to the Housing and Neighborhood Revitalization budget plan to meet the demand for public funding for affordable housing projects.

This Resolution shall become effective immediately upon its adoption.
