To be a paid Youth Farm Intern Supervisor, you must be able to perform the job described and meet the following qualifications.

JOB DESCRIPTION

- Manage and increase the effectiveness of program services and events related to the new Youth Farm at Enoch Davis
- Recruit, train and supervise all Teen Intern staff including staff discipline reports, parent concerns, and incident reports, as needed
- Provide all necessary reports for funders, board of directors and supervisor including attendance, budget and daily program activities
- Participate and at times lead curriculum and a daily schedule while Youth Farm Interns are present
- Ensure all staff is up to date on training requirements
- Organize and manage communication between various speakers and guest presenters who will provide curriculum and direction
- Attend occasional evening and weekend activities and events
