<input type="checkbox"/>	Confirm that the business's insurance coverage includes welcoming pets.
<input type="checkbox"/>	Display pet-friendly guidelines that include pet behavior expectations, owner responsibility assumptions and any other necessary guidelines.
<input type="checkbox"/>	Make safety a priority. Premises will be kept secure and well-lit to protect pets and people.
<input type="checkbox"/>	Provide hydration, relief area access (which can be inside or outside your business) and supplies using recyclable or compostable materials when possible.

<input type="checkbox"/>	Maintain high standards of cleanliness and maintenance for all food and water bowls, products, services and solutions offered for pets. Clean and maintain relief areas waste stations regularly.

<input type="checkbox"/>	Show concern for all guests. As much as possible your business should designate pet-friendly and pet-free zones to accommodate other guests with allergies or sensitivities to pets.
<input type="checkbox"/>	Promote sustainability. In support of the City's green initiatives, businesses will seek solutions that are good for pets, people and the planet. An example is use of eco-friendly waste bags.
