When to Call Codes

Zoning	Illegal property use, setback violations (i.e. encroachments), prohibited business in a residential area, illegal signs, illegal sheds
Nuisance / Blight	Junk vehicles, hazardous dead trees, overgrown yards, outdoor storage of junk, cars parked on the front yard, boats and trailers parked in front yards during unapproved times, commercial equipment parked in residential areas
Building Maintenance	Construction work performed without a permit, such as replacing a roof or extensive remodeling; disrepair such as defective paint, rotted wood, roof damage, broken windows, etc.
Health & Safety	Unsafe structures that are vacant and open to unauthorized access, with severe structural deterioration, or unsanitary conditions posing potentially serious public health or safety hazards
Tenants	Interior inspections of rental units for minimum maintenance, unsafe electrical; dwelling units without working appliances, water or electric service
