- building and maintaining positive and productive relationships with students with disabilities and their families.
- promoting disability awareness among all members of the community.
- coordinating career accommodations and support services.

ARTICLES OF INCORPORATION OF GEORGE'S GRILL MIDTOWN

The undersigned incorporator are individuals 18 years of age or older and adopt the following articles of incorporation to form a nonprofit corporation.

Article I – Name

The name of this corporation shall be **George's Grill Midtown**.

Article II- Registered Office Address

The place in Florida where the principal office of the Corporation is to be located is at 642 22nd Street South, St. Petersburg, Florida 33712, or at such other place as may be subsequently designated by the Board of Directors.

Article III – Purpose

The mission of **George's Grill Midtown** is to coordinate youth development efforts in our community that provides empowerment. The program seeks to increase knowledge, awareness, and opportunities to young adults eighteen years and older from various backgrounds. The program engages and actively involves participants with on-the-job training, which will empower them to be productive citizens and to develop their potential to its maximum.

Article IV – Membership/Board of Directors

This Corporation shall have no members.

The management of the affairs of the Corporation shall be vested in a Board of Directors, as defined by the corporation's bylaws. No director shall have any right, title, or interest in or to any property of the corporation.

The number of directors constituting the initial board of directors is **two (2)**; their names and addresses are as follows:

Article V – Personal Liability

No director if this corporation shall be personal liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the directors be subject to the payment of the debts or obligations of this corporation.

Article VI – Duration/Dissolution

The duration of the corporate existence shall be perpetual until dissolution.

Upon the dissolution of the organization, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the Corporation, distribute all of the assets of the Corporation exclusively for charitable, scientific or educational purposes in such manner and to such qualified organization in organizations as the Board of Directors shall determine. Any of such assets not so distributed shall be distributed in accordance with the direction of any court having jurisdiction in the county in which the principal office of the Corporation is then located exclusively for the aforesaid purposes of the Corporation to such qualified organization or organizations as said court shall determine. For purposes of this Article, an organization is “qualified organization” only if, at the time of receiving such assets, it is operated exclusively for the purposes described in Section 170 (c) (1) or 170 (c) (2) (b) of the Internal Revenue Code of 1986 and is described in Section 590 (a) (1), (2) OR (3) of said code. Any reference in these Articles to a section of the Code shall be interpreted to include a reference to the corresponding provisions of any applicable future United States Internal revenue Code.

8-2: Rental space for community events (Receptions – Weddings – Meetings – etc.). Talents shows – (Kids with disabilities), dances, live entertainment and banquets.

8-3: Lease term of 10 years

8-4: Experience of 8 years in business operating as “George’s Grill – 1431 49th Street South, Gulfport, Florida 33707.” Previous experience operating clubs for entertainment, George’s Penthouse on 34th Street South and Ike’s Lounge on 9th Street South.
