DEAR MAYOR RICK KRISEMAN,

HERE IS A GREAT? IDEA - OF COURSE THAT'S MY OPINION - FOR THE PIER.

1. MOVE THE CHIHULY GLASS MUSEUM AND THEATRE TO A NEW BUILDING ON THE NORTH SIDE OF THE PIER ROAD GOING TO THE PYRAMID. LAND FILL AS NECESSARY TO SUPPORT THE NEW BUILDING.

2. OFFER TO ALLOW RESTAURANTS TO BID TO BUILD ON THE SOUTH SIDE OPPOSITE THE CHIHULY MUSEUM. RESTAURANT'S WATER VIEW SOUTH SIDE WOULD BE SUNNY WITH NORTH WINDS BLOCKED IN THE WINTER AND SHADED IN THE SUMMER.
