#### **EXPLANATION:**

WHEREAS, the City of St. Petersburg's youth are an important and valuable resource; and

WHEREAS, the City of St. Petersburg Parks & Recreation Department applied for and was awarded a grant from the Department in the original amount of \$326,500 to provide funding for meals served in the City's Summer Food Service Program, which provides breakfast and lunch for children aged 18 years old and under; and

WHEREAS, during the FY23 Summer Food Service Program, the Parks and Recreation Department increased the number of meals served to youth in the community that resulted in additional grant funds to be awarded from the Department in the amount of \$1,941.17; and

WHEREAS, the amended amount of grant funds to be reimbursed by the Department for the FY23 Summer Food Service Program is not to exceed \$328,441.17.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of St. Petersburg, Florida, that the Mayor or his designee is authorized to accept additional grant funds from the State of Florida Department of Agriculture and Consumer Services ("Department") in the amount of \$1,941.17 for the City's 2023 Summer Food Service Program for a total amount of \$328,441.17 and to execute all documents necessary to effectuate this transaction.

BE IT FURTHER RESOLVED that there is hereby approved from the increase in the unappropriated balance of the General Fund (0001), resulting from these additional grant revenues, the following supplemental appropriation for fiscal year 2024:
