## St. Petersburg Downtown Waterfront Master Plan 2022 Review and Update

The Downtown Waterfront Master Plan (DWMP) adopted on June 4, 2015, provided the first integrated vision for the city's entire downtown waterfront, establishing a master plan and policy framework of guiding principles for future decision making. This review and update report has been prepared in accordance with the City Charter and Code requirements to review and update the DWMP not less than every seven (7) years after its adoption date.

The DWMP is a conceptual planning document reflecting the community's vision for the future of the city's Downtown Waterfront. The DWMP has a framework that includes six (6) Character Districts that subdivide the plan area into zones of specific use and focus. These Character Districts are located from Coffee Pot Park on the north end to Lassing Park on the south end. The DWMP framework is also based on five (5) overarching Waterfront Dimensions, which consist of guiding values and experiences to be available and applied to all Districts of the public waterfront. Each of the Waterfront Dimensions and the Character Districts have a set of comprehensive waterfront needs that are considered Key Action Items. This report provides an assessment of the Key Action Items, or improvements, that have been completed over the past seven years. This update will be an addendum to the existing DWMP upon approval by City Council.

#### **Character District Descriptions**

The following provides summary descriptions of the six Character Districts detailed in the Key Action Table from the DWMP:


**Coffee Pot District** – This district extends from Northeast Exchange Club Coffee Pot Park to the north end of North Shore Park connected by a long major pedestrian trail system which includes the historic Granada Terrace and the Snell Isle bridge.

**North Shore District** – This district continues the pedestrian/multi-modal trail along the waterfront. It includes large expanses of open passive green space, North Shore beach, and an arboretum, while also providing activity centers including tennis courts, an aquatics center, a baseball field, a fitness center and beach volleyball courts.

**Pier District** – The Pier District is along the edge of downtown and Beach Drive, a distinctive avenue for dining, shopping and pedestrian movement. The district includes both North and South Straub Parks, the Museum of Fine Arts and the Pier. Two yacht basins, providing a Cross Bay Ferry Services between St. Petersburg and Tampa, are located on either side of the pier and are in the foreground of the Straub Parks.

**South Basin District** – This district includes the areas between Central Avenue and the Albert Whitted Airport including the Saturday Morning Market, Al Lang Stadium, Pioneer Park, Albert Whitted Park and Demens Landing. Demens Landing is bounded by the St. Petersburg Marina (central yacht basin) on the

northside and the south yacht basin on the south side. The Mahaffey Theater and Dali Museum are at the south end of the district. This district is also the host of the St. Petersburg Grand Prix.

Bayboro & Salt Creek District - This district is along the southside of Albert Whitted Airport and is located within the Innovation District of St. Petersburg which include St. Pete's higher education (University of South Florida, St. Petersburg), marine science, oceanographic, environmental sciences institutions, business incubation, media studies, and the US Coast Guard, all surrounding the Downtown's Bayboro Harbor area. This area links the nautical, aeronautical and science industries. This district seeks to provide multi-modal linkages and interaction to the lands and businesses surrounding Bayboro Harbor.

Lassing Park District - Lassing Park is adjacent to the Old Southeast Neighborhood and is a large open expansive passive park enjoyed by the immediate neighborhood. This park is host to a large sea grass bed along the shoreline.

#### **Waterfront Dimensions Descriptions**

The following provides summary descriptions of the five Dimensions of the Waterfront from the DWMP as detailed in the second section Key Action Table:

Stewardship of the Waterfront Environment – This dimension of the waterfront realizes a sustainable relationship between the built and

natural environments. It includes a commitment to a healthy bay ecology by implementing best management practices to prevent and repair point source and non-point source urban pollution in the bay. It provides for the protection and expansion of the waterfront ecology and encourages an environmentally resilient relationship with the waterfront, in the form of storm surge protection through natural and man-made techniques to buffer wave action while maintaining water quality and environmental habitat.

**Enhancing the Experience of the Water** – This dimension seeks to expand the St. Petersburg waterfront as a destination for boaters and non-boaters by providing a diverse waterfront access. Marine based recreation is proposed for expansion and enhancement through increased dockage for large and small vessels. Reconfigured basins with efficient organization and secured wave protection will support

waterfront activities, along with opportunities for boat rentals (motorized/non-motorized), water access, and fewer parking lot obstacles.

An Active Waterfront Parks System – This dimension includes diversifying the activities of the waterfront to meet the changing and dynamic community. This provides a balance of the historic character of open greenspace with new opportunities for recreation to serve the community by retaining the traditional sense of relaxed community green space with flexible use, and enhancements and comfort such as shade, water, seating, art, discovery, and play. Specific locations have been identified as nodes for targeted community experiences and places of transformational change.

**Economically Vibrant Downtown Places** — This dimension leverages the potential in-water and upland areas along the water edge. The waterfront should continue to be an asset and venue for economic vitality for the entire community. Access to the water should be a source of social and economic value to the residential neighborhoods. The waterfront should allow small business to energize events and provide limited comforts such as recreational rentals and sundries. The waterfront should provide an opportunity for job creating economic development to support the recreational marine industry, scientific research, education, transportation, and cultural tourism.

A Connected, Accessible Downtown and Waterfront – St. Petersburg will provide continuous linkages, service oriented parking and transit, and increased public access. The St. Petersburg waterfront will prioritize people over automobiles. The community will continue its evolution as an urban place with more pedestrian access to the water's edge, supported by bicycles, and trolley service. Parking will migrate away from water's edge and occur on-street or in parking structures nearby. Navigation will be enhanced with clear wayfinding and include a continuous linked, branded system of trails from the Coffee Pot to Lassing Park.

#### **Key Action Items**

The Key Action Table provides the status of the Key Action Items identified in the Downtown Waterfront Master Plan. Key Action Items are provided for the six Character Districts and the five Dimensions of the Waterfront. Photo documentation of Key Action progress is provided at the end of each subsection of the Table. Each Key Action Item is placed under one of the three Levels of Enhancement that are classified as follows:

#### **Summary of Major Accomplishments**

There have been several major accomplishments that have guided the City's waterfront parks and include: the conversion of Al Lang Stadium to a soccer field, now home of the Tampa Bay Rowdies; installment of wayfinding signage; provision of bike and scooter programs while providing additional buffered lanes for

multi-modal transportation; and, in Lassing Park, the implementation of a habitat restoration and Living Shore by Tampa Bay Watch as part of the Community Oyster Reef Enhancement (CORE) project to stabilize 700 feet of shoreline and provide a hard bottom habitat for fish and wildlife resources while promoting water quality in the ecosystem. However, one project in particular shines above all others, and that is the construction and opening of the new St. Pete Pier<sup>TM</sup>. The St. Pete Pier was planned in accordance with the DWMP and opened in July 2020. The Pier is a 26 acre- park along the waterfront, including five acres over open water. The Pier consists of a beach, playground, splash pad, five dining concepts, an environmental education center, a marketplace, event spaces, waterfront promenade, public art and acres of open space. The Pier has over 80 events a year and has been enjoyed by over 2.5 million visitors a year since its opening.

The St. Pete Pier offers business opportunities and many diverse experiences. The Pier marketplace serves as an incubator for small minority-owned and operated businesses and has provided for business growth and development. The Tampa Bay Watch Discovery Center has free classes, programs and scholarships for summer camps and offers and outreach program that travels to local Pinellas County Title 1 schools. There are five restaurants and concessions to choose from each with various price points options to accommodate all economic levels.

The St. Pete Pier provided environmental stewardship through the minimalization of construction impacts to enhancement of ecological resources to exceedance of Federal Emergency Management Agency requirements. A partnership with Duke Energy provides uniquely designed solar panels for energy efficiency. Other ecological features include: provision of breakwaters to protect sea grass plantings; sea grass mitigation; a stormwater design where runoff is treated through wet and dry retention ponds and swales while eliminating pollutants before entering the bay through the use of a "Downstream Defender" stormwater system; use of best practices to prevent and repair point source and non-point source urban pollution in the bay; and coastal planting of native vegetation in bioswales and freshwater wetlands to attract birds and insects.

The St. Pete Pier is welcoming, accessible and exceptionally well-programmed. The new Pier supports the prioritization of pedestrians with a promenade starting at Beach Drive to the end of the Pier. The goal for the Pier is to provide accessibility to all areas including the playground, beach area, the Discovery Center and trams that are all accessible for pedestrians and wheelchairs. Wayfinding and art walks are provided as part of the Pier experience. The art walk includes pieces from nationally recognized artists including pieces such as Bending Arc (Janet Echelman), First Flight (Mark Aeling), Myth (Nathan Mabry), Morning Stars (Xenobia Bailey) and Olnetopia (Nick Ervinck). Historical storytelling is provided in Benoist Plaza with First Flight, celebrating the first commercial airline flight by Tony Janus.

The character-defining features of the St. Pete Pier are the intrinsic values created by having access to the water. The excellence in design for this project has been recognized by over 20 regional, national and international organizations including the World Landscape Architecture Award, the International Gold Medal for Urban Design, the European Centre American Architecture Award, and the AIA Florida/Caribbean Award of Excellence. The comprehensive, integrated approach to architecture, landscape, engineering, programming and sustainability has given this project a distinctive brilliance.

A sampling of significant projects during the first seven (7) years of the DWMP are provided in the attached *Timeline of Significant Improvements from 2015-2022.* 

#### **Stakeholder Feedback**

The master plan was the result of extensive community outreach including members of the community, Chamber of Commerce DWMP Task Force, stakeholder groups, scientist, technical groups, consultants and city staff. As part of this review and update over 3,200 stakeholders have been invited to attend public meetings through emails and the City's DWMP webpage. These Stakeholders include neighborhood and business associations, the Downtown Waterfront Parks Foundation, St. Petersburg Chamber of Commerce, participants from the 2015 stakeholder meetings, USFSP, and other local businesses. The participants have been invited to evaluate the progress of the master plan and recommend any priorities or changes moving forward. The scheduled meetings with stakeholders and public workshops include:

The workshop presentations included a status assessment of the key actions that were provided in the master plan. Based on two public workshops with approximately 95 persons in attendance, the comments to date include topics such as:

- Conversion of asphalt parking areas into green space and pedestrian areas
- The Saturday Morning Market
- Bicycle repair stations in downtown
- Status pf Bayshore Dr as a pedestrian street concept
- Make Cross Bay Ferry compatible with commuter work schedules
- Future of the US Army Reserve land
- Coastal resiliency
- Support for Albert Whitted Airport
- Recognition of opportunities for environmental stewardship
- Support for the Stormwater Master Plan to reduce pollutants and improve water quality
- Support for stormwater basin plantings with native plant materials
- Continue Living Shoreline programs and mitigation planting
- Boardwalks and platforms in Lassing Park are detrimental to the shoreline
- Provision of kayak facilities from Lassing Park to Coffee Pot Park
- Removal of parking away from water's edge and remove asphalt
- Facilitate pedestrian movement with continuous trail linkages
- Connect Old Southeast using Complete Streets standards
- Continue providing shaded seating, pathways, shade trees, native plantings and open vistas

- Pedestrian bridge between the History Museum and Museum of Fine Arts
- Safety issues for pedestrians on sidewalk along Coffee Pot Blvd with bicycles
- USFSP expansion west of 3<sup>rd</sup> Street
- Shared pedestrian/bicycle paths in Lassing Park

#### **Next Steps and Priorities**

While there are many key actions in the DWMP that still need to be addressed, there are also active projects and studies that are in process within the City that may affect or impact the DWMP. These active projects include:

Albert Whitted Airport Master Plan
Stormwater Master Plan
Marina/Demens Landing Plan
Coastal Resiliency & Community Sustainability Project
Seawall Height Study
Downtown Streetscape Plan

Other potential projects that may impact the DWMP area include: Center for the Arts Master Plan Al Lang Stadium USF Campus Master Plan Update Port Master Plan update

The DWMP contains key actions based on both the character locations (park districts) and themes. A review of key items in each Character District and Waterfront Dimension should be addressed annually based on the City's priorities. In the DWMP, the city has projected available funding for waterfront improvements over the 5, 10, 15, and 20 year periods (2020, 2025, 2030 and 2035, respectively), allowing for the prioritization of improvement projects. The preliminary prioritization criteria in the DWMP includes:


- The project advances 2 or more of the Waterfront Dimensions
  - 1. Stewardship of the Waterfront Environment
  - 2. Enhancing the Experience of the Water
  - 3. An Active Waterfront Parks System
  - 4. Economically Vibrant Downtown Places
  - 5. A Connected, Accessible Downtown and Waterfront
- The project is listed in the city's current 5-year Capital Improvements Program (CIP)
- The project ranks as "top priority" or "continued emphasis" as listed in the Public Opinion Survey and Needs Assessment
- Funding is available to implement the project
- A private partnership is available to implement the project
- The project will stabilize an existing asset and prevent further deterioration

The above active and upcoming projects may drive the need for a more encompassing update sooner than 7-years that will address key actions for these areas that are under review.

Projects that are currently being pursued over the next cycle of the DWMP include:

- Coastal Resiliency at North Shore Beach
- Infrastructure Improvements at Vinoy Park
- Completion of living shoreline at Lassing Park
- Design, permitting and construction of the Bartlett Lake dredging project






