General Guidelines

- Substantially equal in population
- Don't dilute minority voting strength
- Follow census blocks
- Must be contiguous
- Follow significant boundaries

- Should be compact
- Should preserve communities of interest
- Follow charter-specific criteria

General Guidelines (Con't)


- It is impossible to develop a redistricting plan that attains 100% compliance with each criteria
- Individual criteria are balanced in concert with each other, with population being the dominant criterion


