Please be advised that during any of the meetings noticed on this agenda, and for any other meetings for which notice has been provided, such Council Members may discuss issues which could come before these other boards or agencies and that this constitutes the notice thereof.

If two or more elected or appointed officials attend any of the meetings listed on this schedule, discussion cannot take place between these members regarding an item that could come before them for a decision in the future unless minutes are taken and placed on file with the City Clerk.

If any person decides to appeal any decision by City Council or a board, agency, committee or commission, with respect to any matter considered at such meeting or hearing, he or she will need a record of the proceedings and may need to ensure before the meeting occurs that a verbatim record of the proceedings is made to collect the testimony and evidence upon which the appeal is to be based.

The City of St. Petersburg, in compliance with the Americans with Disabilities Act of 1990 (ADA), provides reasonable accommodations for all official city proceedings.
