Pursuant to St. Petersburg City Code section 10-72(c), this form is intended to be filed with the City Clerk by an independent spender that is not required, pursuant to Florida Statutes section 106.03, to file a statement of organization with the Florida Division of Elections, the Pinellas County Supervisor of Elections, the St. Petersburg City Clerk, or any other filing officer in the state.

Because this form is intended to be used by both individuals and entities, not all sections of the form will be filled out. Specifically, if the form is filled out for an individual, the following sections (for entities) will be left blank: 4, 5, 6, and 10; and if the form is filled out for an entity, the following sections (for individuals) will be left blank: 2–3. These sections are indicated by red italic text for convenience.
