## INSTRUCTIONS FOR SUPPLEMENTAL INFORMATION—ENTITY CONTRIBUTORS

Pursuant to St. Petersburg City Code section 10-74(c)(1), if any contribution listed on an individual spending report is contributed by an entity (including any corporation, company, limited liability company, limited partnership, business trust, business association, or other similar entity), the independent spending report must also include the name of an individual serving as president, managing member, or CEO or who otherwise exercises control over the entity, along with the name of that individual's position or a description of that individual's role in controlling the entity.

Accordingly, if any contribution listed on City form SP-CO-513A was received from from an entity (as indicated by the "E" in field (8) on that form), the independent spender must also submit this City form SP-CO-513E as part of the independent spending report, and for each row on form SP-CO-513A that reflects a contribution from an entity, there should be a corresponding row on this form to provide the required information about that entity.

This form must be completed in its entirety, and the City Clerk may reject any form that is not completed in accordance with applicable law or the instructions on this form. - (1) **Name:** Enter the full name of the independent spender shown on the corresponding City form SP-CO-513A.
- (2) **I.D. number:** Enter the identification number (if any) shown on the corresponding City form SP-CO-513A.
- (3) **Cover period:** Enter the cover period dates shown on the corresponding City form SP-CO-513A.
- (4) **Page:** Enter the page numbers for this form (e.g., 1 of 3). Page numbers should not be continued from the corresponding City form SP-CO-513A.
- (5) **Date:** Enter the date the contribution was received, as shown on the corresponding statutory report and City form SP-CO-513A.
- (6) **Sequence number:** Enter the sequence number, as shown on the corresponding statutory report and City form SP-CO-513A. Because this form is only for entity contributors, it is likely that the sequence numbers will not be continuous on this form.
- (7) **Entity name:** Enter the full name of the contributor entity, as shown on the corresponding City form SP-CO-513A.
- (8) **Controlling individual:** Enter the full name of the name of an individual serving as president, managing member, or CEO or who otherwise exercises control over the entity.
- (9) **Position or role:** Enter the name of that individual's position (e.g., "CEO" or "President") or a description of that individual's role in controlling the entity.
- (10) **Amendment:** If the information about this contribution is not being amended, leave this field blank. Otherwise, if this is an amendment of the *statutory report*, enter the code used on the corresponding row of the statutory report (i.e., "ADD" or "DEL"). But if this amendment applies only to the *local* report (e.g., you are changing the name of the controlling individual listed on this form), enter "CITY" in this field to indicate that the corresponding row of the statutory report has not changed and that this change is limited to the row on the previously filed version of this form.
