IT IS FURTHER UNDERSTOOD THAT THE DEPOSIT AMOUNT (\$75.00 PER SLIP/LISTING) SHALL BE RETAINED BY THE MARINA ON A NON-INTEREST BEARING BASIS UNTIL (1) CANCELLATION OF THIS AGREEMENT BY EITHER PARTY; OR (2) ACCEPTANCE BY REGISTRANT OF A SLIP WHICH HAS BECOME AVAILABLE AND FOR WHICH THE REGISTRANT HAS QUALIFIED BY VIRTUE OF HIS OR HER POSITION HELD ON A LIST.

IF THE REGISTRATION IS CANCELLED BY THE REGISTRANT, THE AFOREMENTIONED DEPOSIT OF \$75.00 PER LISTING, SHALL BECOME REFUNDABLE TO THE REGISTRANT VIA THE CITY OF ST. PETERSBURG'S REGULAR DISPERSMENT PROCEDURES. IF A SLIP BECOMES AVAILABLE FOR WHICH THE REGISTRANT HAS QUALIFIED, THE REGISTRANT SHALL BE NOTIFIED OF THE AVAILABILITY AND SHALL HAVE TEN DAYS FROM THE DATE OF NOTIFICATION IN WHICH TO ACCEPT OR REFUSE THE AVAILABLE SLIP. NOTIFICATION SHALL BE DEEMED GIVEN WHEN THE REGISTRANT RECEIVES ACTUAL NOTICE OF THE AVAILABILITY OR WHEN THE MARINA MAILS A NOTICE BY FIRST CLASS MAIL TO THE LAST KNOWN ADDRESS OF THE REGISTRANT. IF THE REGISTRANT REFUSES TO ACCEPT THE **AVAILABLE** SLIP OR FAILS TO RESPOND IN WRITING WITHIN THE AFOREMENTIONED TIME, THE REGISTRANT SHALL BE REMOVED FROM THE LIST THEREBY FORFEITING ANY POSITION ON THE LIST HELD BY THE REGISTRANT AND RESULTING IN THE REFUND OF THE REGISTRANT'S \$75.00 DEPOSIT.

IF THE REGISTRANT ELECTS TO ACCEPT THE AVAILABLE SLIP FOR RENTAL PURPOSES; THIS ACCEPTANCE MUST BE IN WRITING AND A LEASE MUST BE EXECUTED WITH THE MARINA WITHIN TEN DAYS OF THE DATE OF THE NOTICE ACCEPTING THE AVAILABLE SLIP. IF A LEASE IS NOT EXECUTED WITHIN THIS TEN DAY PERIOD, THE MARINA MAY CANCEL THE LISTING AND REFUND THE DEPOSIT. THE 75.00 DEPOSIT HELD BY THE MARINA FOR THIS LISTING SHALL BE APPLIED AGAINST THE FIRST MONTH'S RENT OF THE LEASED SLIP. REGISTRANT SHALL HAVE THE OPTION OF RETAINING OR CANCELLING ANY AND/OR ALL OTHER LISTING THAT MAY BE HELD AT THE TIME OF THE ACCEPTANCE OF THE AVAILABLE SLIP.
